

1. The workload of the present is calculated taking into consideration the number of students enrolled in the aided faculties/department/subjects functioning in the college.
2. Enrolment in the college itself is mandatory for the faculties/units/subjects mentioned in the proposal submitted by the college for designation and the number of students certified by the university.
3. Mandatory number of students for grant and the hours maximum number of students for workload calculation should be taken into consideration.
4. The batch (group) of the number of students prescribed as per the government rules will be mandatory for the demonstration.
5. The hours prescribed for training/demonstrations/tutorials; project work must be as per the rules prescribed by the government.
6. According to the posts sanctioned to the reservation point list must be validated by the prescribed authority as per the prevailing reservation policy of the government.
7. In case of reduction in the number of students in the next academic year or reduction in the workload of the aided department due to other reason, the sanctioned number of posts will be reduced.
8. As per the prevailing policy of the Government as per permissible post no recruitment shall be made without prior permission of the Government. If irregularity is found in the appointment to such sanctioned post, the same shall be disallowed in the determination of grant. The management and the college will be responsible for the irregular appointment.
9. The post are sanctioned based on the grant – eligible workload of the college. For recruitment to sanctioned posts. It is necessary to independently submit proposal and obtain a no-objection certificate as per the prevailing policy and procedure of the Government.

NOTE: - The following terms & conditions regarding reservation shall not be applicable to colleges having minority status.

Terms and Conditions

- 1) So, for the recruitment of these posts, the posts should be filled according to the roster of the posts which have been reserved from the backward classes. The posts shall be filled after checking Category wise social reservation, apart from social reservation economically weaker section reservation and parallel reservation (women, sportsmen, disabled etc.) Backlog posts be filled on priority.
- 2) While filling up the teaching posts, the educational qualifications / qualifications required for the posts shall be taken into consideration as per the prescribed provisions of the University Grants Commission notification dated 30.06.2010 as well as the amendments made thereto from time to time and the prescribed provisions of the Notification dated 26.8.1999 in respect of non-teaching posts as well as the Maharashtra Public University Act, 2016. The prescribed provisions and the Government resolutions issued by the Government from time to time should be strictly followed. While appointing the posts, the selection should be done only through the prescribed selection committee constituted as per the prevailing university law. In case of any future court cases arising in connection with cancellation of posts filled without following the prescribed procedure, the joint director of the department shall be solely responsible for the same.
- 3) Signature of the concerned institution to determine the eligibility of the candidates by considering the provisions of the prevailing rules / regulations for the selection process for the post of Teacher Non-Teaching. Also, if the appointment is given in defiance of the prevailing rules, the concerned Regional Joint Director / University / Principal / Management will be fully responsible while recruiting
- 4) If the posts of teaching & non-teaching staff are created elsewhere by deputation, no new appointment will be made to the said vacant post under any circumstances & such posts are not included in the proposal.
- 5) If the employees working in the post of lien and non-Teaching cadre are posted elsewhere on deputation, no fresh appointment will be made to the said vacant post under any circumstances and such posts are not included in the proposal. If lien is retained by an employee working in a teaching or non-teaching post, the new appointment shall in any case till the lien is extinguished on the said vacant post will not be done and such posts have not been included in the proposal.
- 6) While filling up the teaching and non-teaching posts, the list of the said posts should be filled strictly following the qualifications, experience, professional qualifications prescribed by the Government of Maharashtra from time to time. In case of irregularity in this regard, the Regional Joint Director / University / Principal / Management of the institute will be held responsible.
- 7) The Joint Director (Higher Education) shall be responsible for determining the permissible teaching and non-teaching posts in the sanctioned batch, the student capacity of the batch and ensuring that the posts are sanctioned by complying with all necessary criteria and rules.
- 8) The Regional Joint Director (Higher Education) shall be responsible for re-verification of additional adjustments made to teaching & non-teaching staff.
- 9) The process of filling up the post should be completed within six months, after six months the no objection certificate will automatically remain cancelled.
- 10) Approval to be given to above posts as well as appointments to be given to those posts are subject to the special permission filed in the Hon'ble Supreme Court Special permission letter No. 15737/2019 & others judgments. It will be mandatory to mention clear instructions in the appointment order to be issued to the candidate.
