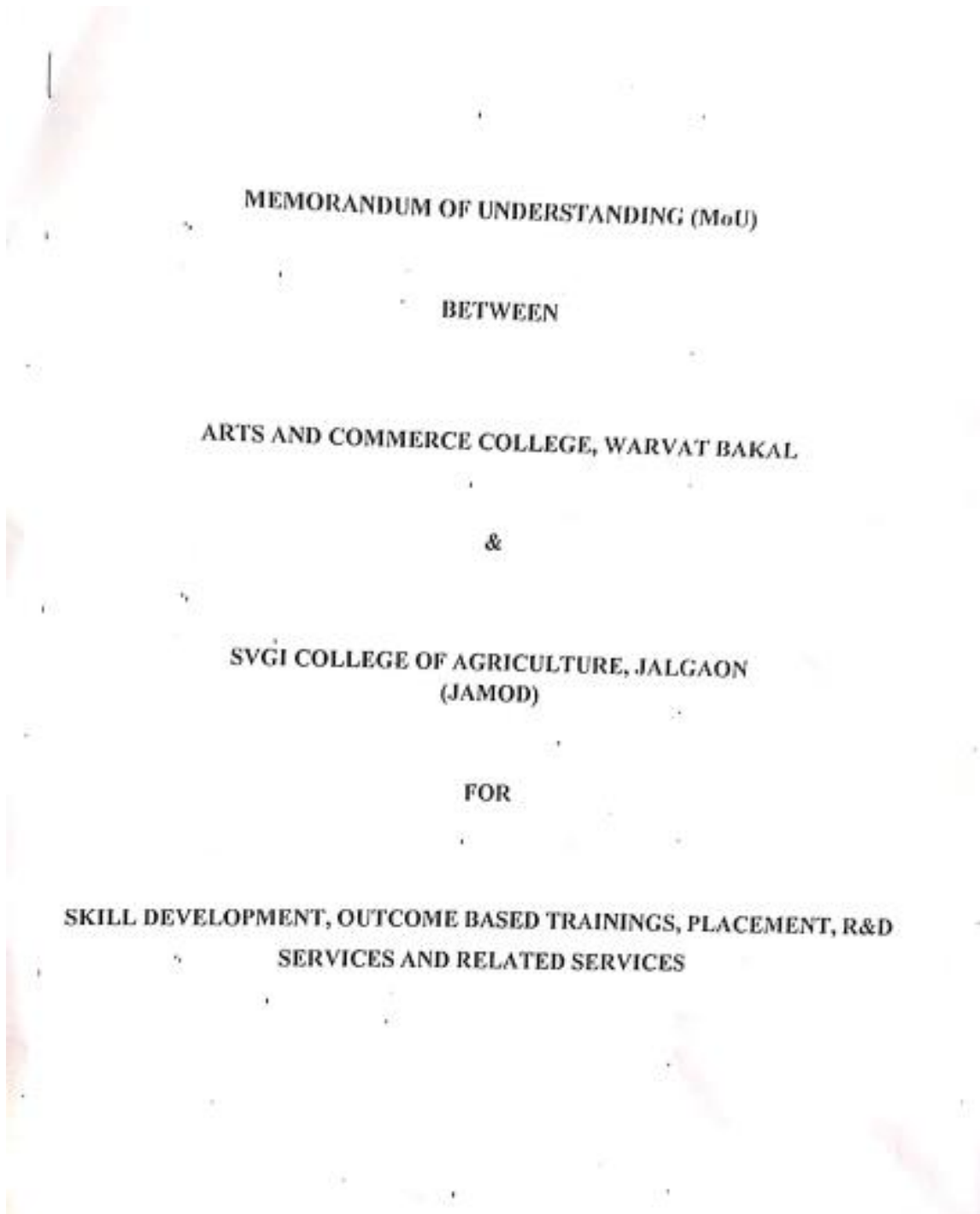



1. Preamble

College Washim should join their hands in academics and research. This would help to increase the academic standards and students quality. This also helps in tackling particularly the local problems and work together for the sustainable development of the area.

ABOUT DEPARTMENTS:

DEPARTMENT OF ZOOLOGY

Arts, Commerce College Warwat Bakal, Tq. Sangrampur Dist. Buldana

The Department of Zoology was established in 2009. It is one of the largest departments in the science faculty. The college offers courses in Zoology H.S.C. and B.Sc. with competent faculty. The department has well equipped laboratory containing all the necessary apparatus, instruments and chemicals that completely satisfy the requirement of experiment. Faculty members guide and encourage the students to participate in science exhibition, Avishkar competition, seminar competition, Zoo-quiz competition, and study-tours. 2. Collaboration

ACCWB (Arts Commerce College Warwar Bakal (Sangrampur) and RACW (R. A. Arts, Shri M. K. Commerce and Shri S. R. Rathi Science College Washim) have mutually agreed to collaborate with each other in following areas,

- Teaching, learning and Evaluation are important areas of science with special emphasis on research.

- Joint field work, students training programs etc.
- Students coaching for project
- Students skill orientated training workshops
- Any other areas of mutual interest.

The available facilities and manpower of ACCWB and RACW will be utilized with mutual consent and subject to the feasibility. Both parties agreed to enter into a collaborative understanding on the terms and enumerated in this MoU.

3. Terms of collaboration

- a) ACCWB and RACW agree to enter into detailed agreements on case-to-case basis, with a defined objective, specifying the scope of work and mutual obligation, terms and conditions, financial arrangements, Intellectual property rights and similar contractual obligations.
- b) ACCWB and RACW agree to obtain prior permission from the concerned authority in any coaching program that would be carried out by using the ACCWB and RACW infrastructural facilities.
- c) In case, either party wins a consultancy project by projecting this MoU a liability is created immediately in respect of royalty/premium due to either party. Either party shall concur with the liability to the extent of contribution to the output of the project. Both the parties will arrive at the exact amount of liability after mutual consent.

4. Disclaimer

This MoU is not intended by ACCWB and RACW to constitute, create, give effect to, or otherwise recognize a joint venture, agency, partnership, or formal business organization of any kind. Each party here shall act as an independent entity and neither shall act as an agent of either organization for other purposes. Neither party has the authority to bind the other party.

5. Non-exclusivity

The agreement reflected by the provision of MoU is non-exclusive in nature and both the parties can enter into co-operative arrangements with other parties to suit their organizational needs.

6. Confidentiality

The parties understand that in the association, they shall have access to confidential information provided by the other party. Accordingly, the parties agree that such information which is by its nature, not confidential or which is in the public domain or which the party comes to know about other than through violation of any law of legal obligation, provided that such party may be entitled to disclose such information if legally required to be disclosed to a competent authority. Failure to maintain confidentiality shall entitle the affected party to terminate the MoU.

7. The MoU would remain valid for a period of Five years from the date it is signed by the parties and is renewable on mutual consent for such further period as agreed upon.

8. Terms and Review

The MoU shall be reviewed at the end of one year from the date of signing of this MoU. Either party can terminate the MoU after giving one month's notice to the other party subject to fulfillment of commitments already agreed upon.

9. Amendments

III. Specific roles and responsibilities of each party:-

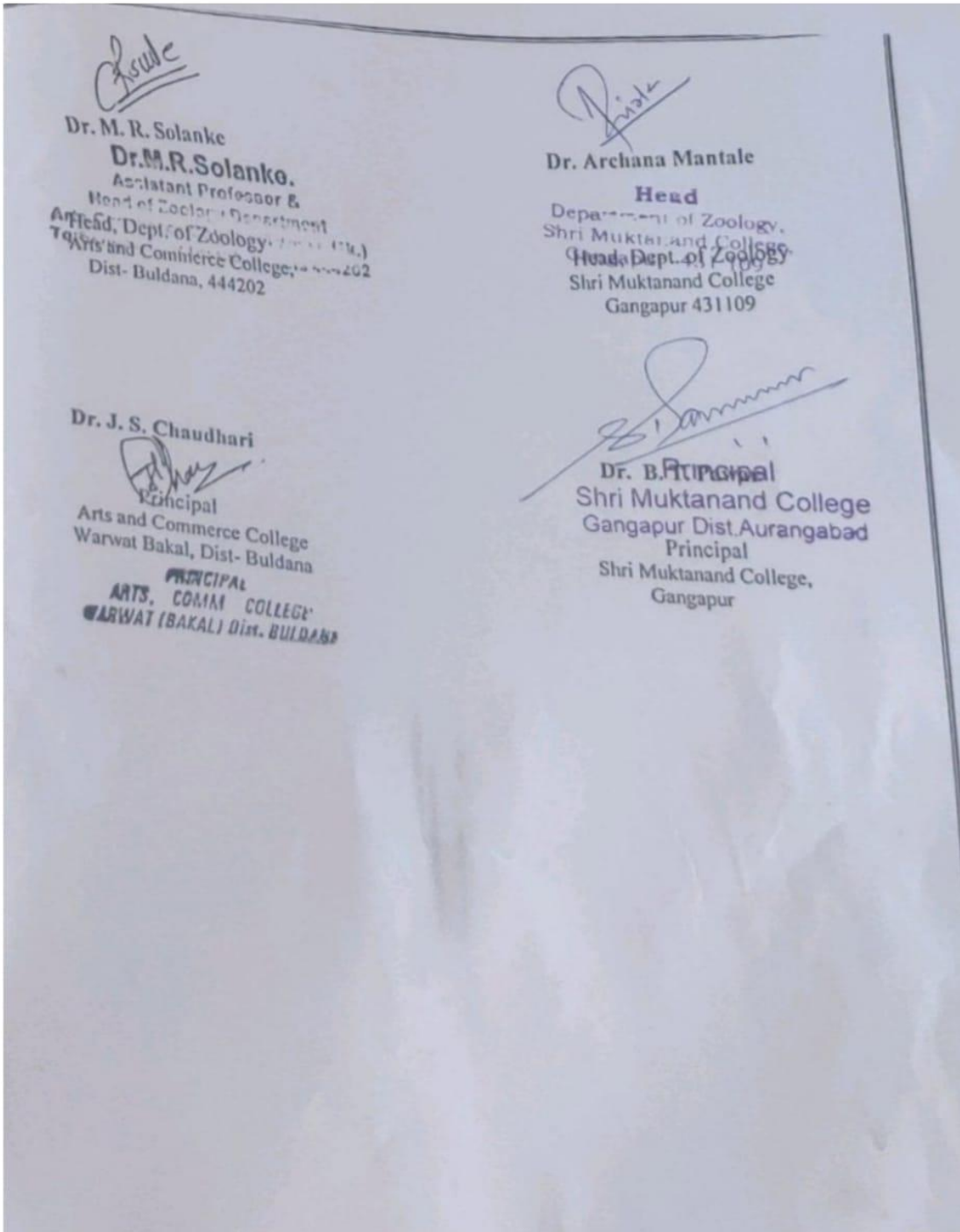
