1) So, for the recruitment of these posts, the posts should be filled according to the roster of the posts which have been reserved from the backward classes. Th posts shall be filled after checking Category wise social reservation, apart from social reservation economically weaker section reservation and parallel reservation (women, sportsmen, disabled etc.) Backlog posts be filled on priority.

2) While filling up the teaching posts, the educational qualifications / qualifications required for the posts shall be mion into consideration as per the prescribed provisions of the University Grants Commission notification dated 30.66.2010 as well as the amendments made thereto from time to time and the prescribed provisions of the Notification dated 26.8.1999 in respect of non-teaching posts as well as the Malazashra Public University Act, 2016. The prescribed provisions and the Government resolutions issued by the Government from time to time should be strictly followed.

While appointing the posts, the selection should be done only intrough the prescribed selection committee constituted as per the prevailing university law. 4) If the posts of teaching denon-teaching staff are created elsewhere by depotation, no new appointment will be made to the said vacant post under any necumstances & such posts are not included in the proposal.

5) If the employees working in the post of lien and non-Teaching cades are posted shewhere on depotation, no fresh appointment will be made to the said vacant post under any circumstances and such posts are not included in the proposal. - 3. Mandatory number of students for grant and the hours maximum number of students for workload calculation should be taken into consideration.
- 4. 4. The batch (group) of the number of students prescribed as per the government rules will be mandatory for the demonstration.
- 5. The hours prescribed for training/demonstrations/tutorials; project work must be as per the rules prescribed by the government.
- 6. According to the posts sanctioned to the reservation point list must be validated by the prescribed authority as per the prevailing reservation policy of the government.
- 7. In case of reduction in the number of students in the next academic year or reduction in the workload of the aided department due to other reason, the sanctioned number of posts will be reduced.
- 8. As per the prevailing policy of the Government as per permissible post no recruitment shall be made without prior permission of the Government. If irregularity is found in the appointment to such sanctioned post, the same shall be disallowed in the determination of grant. The management and the college will be responsible for the irregular appointment.
- 9. The post are sanctioned based on the grant eligible workload of the college. For recruitment to sanctioned posts. It is necessary to independently submit proposal and obtain a no-objection certificate as per the prevailing policy and procedure of the Government.
