Internal assessments in the institute encompass various modes such as Written Tests, Practical Examinations, Multiple Choice Questions (MCQs), Online Exams, Quiz Competitions, Assignment Submissions, Project Reports, Seminar Presentations, Group Discussions, Survey Methods, Study Tours, Industrial Visits, and Field Visits. Transparency is maintained through the display of students' marks and performance on departmental notice boards. After the evaluation of unit tests, answer sheets are provided to students for their review. If any grievances arise regarding marks or performance in internal activities, students can approach their subject teachers for resolution. Subject teachers address these concerns and allotted marks. If a student remains dissatisfied, the matter escalates to the Head of Department for further review. If students unsatisfied on HOD level, students can approach to Students grievance redressal committee (SGRC) of the college with written complaint. Grievances associated with internal examinations are promptly addressed and resolved.

The institute conducts semester university examinations according to the university's schedule, using question papers and answer sheets provided by the affiliated university. Question papers are set and moderated in alignment with the prescribed syllabus. If a student's grievance pertains to the question papers, it is communicated to the university authorities, specifically the Board of Examination. The Board of Examination forwards the matter to the Board of Studies for deliberation. Once the Board of Studies reaches a decision, the Board of Examination resolves the students' grievances accordingly.
